Dear Parents and Carers,

Following today's Department of Education update I am able to share the latest advice 16 03 2020:

Current advice remains in place:

No education or children's social care setting should close in response to a suspected or confirmed COVID-19 case unless advised to do so by Public Health England.

The Chief Medical Officer has advised that the impact of closing schools on both children's education and on the workforce would be substantial, but the benefit to public health may not be. Decisions on future advice to education or children's social care settings will be taken based on the latest and best scientific evidence, which at this stage suggests children are a lower risk group.

What you need to know:

staff, young people and children should stay at home if they are unwell with a new, continuous cough or a high temperature to avoid spreading infection to others. Otherwise they should attend education or work as normal

if staff, young people or children become unwell on site with a new, continuous cough or a high temperature they should be sent home

clean and disinfect regularly touched objects and surfaces more often than usual using your standard cleaning products supervise young children to ensure they wash their hands for 20 seconds more often than usual with soap and water or hand sanitiser and catch coughs and sneezes in tissues

## Handwashing advice

The most important thing individuals can do to protect themselves is to wash their hands more often, for at least 20 seconds, with soap and water. Public Health England recommends that in addition to handwashing before eating, and after coughing and sneezing, everyone should also wash hands after using toilets and travelling on public transport.

We will ensure for those children without access to a suitable device (laptop, tablet or PC) that there will be paper and pencil pieces of work for them to access. Please can you inform us via the admin@gbpa.org.uk email if your child does not have access to a suitable device.

For those children currently not in school who are being isolated but not exhibiting symptoms, please encourage your children to read and access online platforms such as Purple Mash and TimesTable Rockstars.

Login details will be written in the children's home school books or diaries and for children who are not on site tomorrow, you will receive the information via email.

The health and wellbeing of all our school community remains our number one priority and we will keep you updated on any further developments.
